MOTION MADE BY SC/SB TO APPROVE THE February 11th, 2024 minutes. All in favor. None opposed.

4. Concept discussion: Tax map R28, Lot 8.A07 Catterall Road. Applicant Craig and Lindsay Myers. Surveyor-Tom Smith explained that they are looking into how best to develop this property. Originally the Myers planned to build their home here, but are now looking at ideas of building individual cabins for year round short term rental. The cabins would be one bedroom with maybe a loft, on concrete slabs. Looking at maybe four cabins.

The board and Tara Bamford suggested the applicants look into the OSPRD regulation as this might best fit their needs and would not preclude them selling the units in the future as part of a condominium style of ownership. It would require subdivision approval and a Conditional Use permit, both fall under the purview of the Planning Board The access road would have to be built to town standards for safety reasons. The wetlands in the vicinity of the development should be flagged for accuracy. Other suggestions for similar development are to use the cluster subdivision regulation which would need a

Conditional Use permit and Subdivision approval. Traditional seasonal cottages would need special exception from the ZBA and Site Plan approval from the planning board.
