Board of Selectmen Minutes 03/18/2013

Selectmen's Meeting Minutes
Meeting Date: March 18, 2013

Selectmen Present: Michael Carver (MC), Peter Nightingale (PN), Conrad Farnham (CF)
Administrative Assistant: Barbara Menchin

MC opened the meeting at 3:00 pm

Bills and manifests were approved. MC made a motion to approve the minutes for the March 11, 2013 meeting, PN 2nd so voted.

SELECTBOARD:

PN made a motion to select MC as chairman of the Board of Selectmen, CF 2nd, so voted.

ADMINISTRATIVE ASSISTANT:

BM spoke to the Board regarding the newly appropriated land located on Ecology Road. She informed the Board that Mr. Thomas Smith (surveyor) stated that instead of doing a sub-division, he would do a lot-line adjustment.

BM presented the Board with a fine from the Department of Labor to the Grove Hill Cemetery Association for non-payment of worker's compensation in the amount of \$17,800.00. She stated she would contact the town lawyer to see what needed to be done to avoid the town paying the fine.

BM spoke to the Board regarding creating a new email address for the "old" town administrator computer stating there was an extreme amount of email coming through that didn't have anything to do with the town. The Board requested her to contact Roadrunner and change the email address.

DEPARTMENT HEAD: Fred Garofalo (Lisbon/Lyman/Landaff Recycling Center)

FG requested a signed requisition to purchase the concrete to pour the floor at the recycling center.

TOWN CLERK/TAX COLLECTOR (Jennifer Trelfa)

JT spoke to the Board regarding deeding properties for back taxes. She requested permission to contact the town lawyer with questions regarding this. The Board approved.

PUBLIC INPUT: Mark Hersey

Mr. Hersey spoke to the Board regarding the condition of his road stating it had not been completely graded since 2011. He stated part of the road had been graded in 2012 but not his section. The Board stated they would speak with Mr. Kevin Clement (Department of Public Works). All of the Board members stated they would drive by to look at the road.

PUBLIC INPUT: Donnie Clough

Mr. Clough spoke to the Board regarding the newly appropriated land on Ecology Road. He stated he had spoken to Mr. Don Leavitt regarding taking a small part of that piece of land for a larger buffer between Mr. Clough, Mr. Leavitt and the Town. The Board stated they would speak with Mr. Tom Smith (surveyor) on the easiest way to accomplish this.

MC made a motion to adjourn, CF 2nd, so voted.
