Selectmen's Meeting Minutes
Meeting Date: April 2, 2012

RAR opened the meeting at 4:00 pm

Bills and manifests were approved. PN made a motion to accept the minutes of the Board's March 26, 2012 meeting minutes MC 2nd, so voted all.

SELECTMEN MATTERS:

The Board discussed a recent letter they received from Mr. Stan Borkowski (Building/Code Inspector) regarding a town-owned property where people have been dumping trash.

The Board requested RP to talk to individuals regarding the 250th Lisbon Town Anniversary. The Board would like to meet on Monday, April 9, 2012 to set things in motion.

The Board will be meeting Tuesday, April 4, 2012 at 1:00 pm to meet with Department Heads.

TOWN ADMINISTRATOR:

RP presented the Board with the new 911 Map for Lisbon.

RP showed the Board a coverage map for NCIC showing where people have wireless internet coverage.

The Board looked at a map that was sent from the Department of Transportation showing the proposed area of work that will be done this year in the area of Catterall Road on Route 302.

The Board requested RP to follow up with Ms. Stacey Cole (Grove Hill Cemetery Trustee) regarding her follow-up with Mr. Joe Nyberg of the Lisbon Trustee of the Trust Funds.

RP informed the Board there will be an Emergency Management meeting on Friday, April 27, 2012 at 8:00 am at the Railroad Station.

The Board discussed insurance coverage for the Lisbon Historical Society. RP will check to see if their activities could be covered under Town Insurance.

The 4-H Club will not be holding their meetings/activities at the Railroad but instead will be holding them at the Lisbon Library.

RP spoke about the financing of the 1-ton truck. The Board requested RP to check for various rates.

RP informed the Board that the NH Governor's Commission on Disability would like to meet on May 31, 2012. This will be an all day work session.

PUBLIC INPUT:

A resident came in to speak with the Board regarding waiving the interest on his real estate taxes. The Board informed the resident that they would take his proposal under consideration. The Board stated they would like to talk to Ms. Jennifer Trelfa (Town Clerk/Tax Collector) to see what some options would be to assist the resident.

MC moved to enter non-public session per RSA 91-A:3 II (c) for the purpose of discussing a personnel issue. RAR 2nd. All members voted in favor taking RP with them.

Resumed public session. MC moved to seal the minutes. RAR 2nd. So voted.

As there was nothing further to discuss, MC made a motion to adjourn, PN 2nd, so voted.
