**Approval of minutes from June 19th BOS meeting:** Arthur Boutin made a motion to approve the minutes from the 6/12/2017 BOS meeting and Brian Higgins seconded the motion. All were in favor of the motion.

**Intent to Cut R36/Lot 3 Northy Road:** The application for the Intent to Cut was filled out incorrectly, that being said I (Krystle Dow) placed a call to the logger to let him know that a **new** Intent to Cut application needs to be filled out with the correct road name on it.

**Quitclaim Deed for U-08 Lot 3 Elliot Road Lisbon NH to Charles Weed:** Town Council has written up the deed and all the selectboard members agreed and signed the deed.

**Recommendation for PT T/A by Town Committee:** The Committee had recommended two candidates that they believe are the best qualified for the position. This position will be a flexible 30 hours a week.

Info obtained from Town Council: Town Council has recommended that each town parcel that is sold has a minimum bid placed upon it. The board has some properties that they want to list in the paper. Minimum bid of \$2,000.00

Minimum bid of \$23,900.00

Minimum bid of \$2,000.00

Map U06 Lot 08 = .670 Acres  
Minimum bid of \$1,000.00

Map U07 Lot 40 = .420 Acres  
Minimum bid of \$750.00


Map U08 Lot 01 = 1.880 Acres
