## **SPECIAL EXCEPTION CRITERIA**

- 8.03.1 The Specific site is an appropriate location for the use.
- 8.03.2 Property values in the district will not be reduced by this use.
- 8.03.3 The use will not adversely affect the adjacent area and there are no reasonable objections by the owners of the abutting land.
- 8.03.4 No nuisance or unreasonable hazard will result.
- 8.03.5 Adequate and appropriate facilities will be provided for the proper operation and maintenance of the proposed use.

*In accordance with both the Bylaws of the Zoning Board of Adjustment and the Town of LISBON Zoning Ordinance, all completed forms, plans and fees for Use Variance, Area Variance, Special Exception, and Appeal of Administrative Decision applications must be submitted no later than twenty (20) days prior to a regularly scheduled Zoning Board of Adjustment meeting, not including the day of the meeting. Items submitted either after this date or incompletely filled out will not be placed on the Agenda. Those applications will be deferred.*

For purposes of receiving testimony only and not for purposes of notification, the term ‘abutter’ shall include any person who is able to demonstrate that his land will be directly affected by the proposal under consideration. For purposes of receipt of notification by a municipality of a local land use board hearing, in the case of an abutting property being under a condominium or other collective form of ownership, the term abutter means the officers of the collective or association, as defined in RSA 356B:3, XXIII.”**
