**Approval of minutes from May 9th BOS meeting:** Brian Higgins made a motion to approve the May 9<sup>th</sup> BOS meeting minutes as written and Arthur Boutin seconded the motion. All were in favor of the motion.

**Update on Breezy Hill:** Scott Champagne had drafted two letters and sent them to town council. Scott stated that the town council reviewed the cease-and-desist letters and informed the town that they can charge weekly fines for violations. The board discussed the issue and stated that for the Casey Property on Breezy Hill the fine would be \$600.00 a week for violations and then the fine for Serenity Lane will be \$200.00 a week for violations. Scott stated that he would talk to the Town Attorney about a summary judgement.

**Oath of Office:** There is an Oath of Office for the Conservation Commission recommended by Katrine Barclay. This is for Rebecca (Becky) Lockwood to be on the Conservation Commission. Scott Champagne made

a motion to approve, and Arthur Boutin seconded the motion. All were in favor of the motion.

**Intent to Excavate:** There is an Intent to Excavate for Map and Lot R17 L17. This has already been mailed to the State of NH and they mailed it to us for signatures. This is for the Locke Pit. Scott Champagne made a motion to approve, and Arthur Boutin seconded the motion. All were in favor of the motion.

**Request for Use:** There is a request for use of the Town Hall form. This is from the Historical Society, and they are requesting use of the Town Hall on June 22, 23, and 24, then again on June 27, 28, and 29. This is for the conservation of historic stage curtains. Scott Champagne made a motion to approve and waive the fees and Arthur Boutin seconded the motion. All were in favor of the motion.

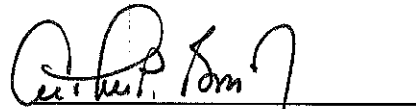
