## Selectmen's Report

Lisbon (n.) \'lis-bon\ (1763): 1. a small town in Northern New Hampshire, "small town with a big heart" 2. "Go Lisbon" a forward looking/moving group of dedicated people. This is what we would envision the definition of our town would look like in Webster's Dictionary 2017.

The Select Board would like to acknowledge and thank the Town Employees for all of their dedication and hard work during this past year, your efforts did not go unnoticed. The Board is grateful to the many Lisbon taxpayers along with community & volunteer groups that have encouraged and positively engaged the Board, as well as the support and guidance we have received from previous board members. We look forward to this trend continuing. The Board extends its sincere appreciation for our neighboring towns of Landaff and Lyman as they were of great assistance to this Board; a special thank you to Donna Clark for your time and patience.

In April, using an employment agency to review and screen qualified applicants the Board hired a part-time assistant to work 27 hours a week. Eventually, the Board offered our assistant a permanent part time position of 30 hours per week and were very fortunate to have the position accepted by Krystle Dow, now employed by the Town of Lisbon as our part-time Administrative Assistant/Bookkeeper. Our next step in staffing was to fill the Town Administrator position. A committee of town employees & taxpayers was formed for the process. After interviews (or maybe it was interrogations), we welcomed Sharon Penney to the position in mid-July.

We replaced an antiquated and overworked computer server by installing fiber optic lines to speed up the network system and replaced the analog telephone system with a digital telephone system within the offices of 46 School Street.

In October, several town owned properties were auctioned off to private ownership.

Lisbon Tax Cards are now available by printing them from the town's web site via CAI

Technologies. We are hopeful to digitally improve the accuracy of our online property maps by reconciling tax map property lines with GIS mapping and are upgrading a third of the town at a time.

The Selectmen's meetings can be heard on-line at the town's web site, for your review. We look forward to continuing progress for Lisbon in 2018.

MINUTES OF THE TOWN OF LISBON TOWN MEETING HELD ON MARCH 21, 2017

Moderator: my name is Robert Cook I'm the town moderator, I'm also the chair of the conservation commission.

The meeting was called to order by Moderator Robert Cook at 7:00pm. Mr. Cook thanked everyone for attending and noted that now is the time for all to come together and work as a team. In light of the resignation of all three Selectmen on Monday evening Jennifer Trelfa, TCTC had been on the phone to the state and was able to receive approval to hold the election and the town meeting and he thank Jennifer. As per state requirements three individuals were sworn in to sit as Selectmen for the day; Charlotte Derosia, Mike Carver and Arthur Boutin. Introduction of the head table M.Carver, A. Boutin, J. Trelfa, TCTC (C.Derosia had retired for the remainder of the evening), Introduction of Department Heads.

## Pledge of Allegiance

Robert Cook, Moderator reviewed the rules of the meeting, the voters did not object to the rules presented.

To the inhabitants of the Town of Lisbon, in the County of Grafton, and State of New Hampshire qualified to vote in the Town affairs;

You are hereby notified and warned to meet in Lisbon Regional School in said Town of Lisbon, New Hampshire on Tuesday the fourteenth Day of March, 2017 at ten o'clock in the forenoon at which time polls shall open at ten o'clock and not close earlier than nine o'clock in the evening, to act upon the following subjects. All Articles except Article 1 are to be considered at seven o'clock in the evening.

## ARTICLE 1: To Elect All Town Officers

## ARTICLE 2: Hear reports of Agents, etc.

To hear reports of agents, and special committees heretofore chosen and pass any vote related thereto

## Article moved by A. Boutin, second by M.Carver

J.Trelfa explained that some agent/department reports did not make it into the Town Report. The intention is to get those reports posted onto the towns web page.

D. Blodgett - Can you have printed reports as well.

J. Trelfa - Yes we will.

R. Houston - How many police officers do we have

Chief Pinson – 3 full-time, 4 part-time, statement to the fact that this gives us 24 hour coverage

R. Houston - How long have we had 24 hour coverage

Chief Pinson – I have been on the department for 11 years and we have had 24 coverage for that period of time. Explanation continued as to the hours and coverage

## ARTICLE 3: Purchase of skid steer

To see if the Town will vote to raise and appropriate the sum of Twenty-three Thousand One Hundred Eighty-Four Dollars (\$23,184) for the purchase of a new Skid Steer for the transfer station. (This appropriation is in addition to Warrant Article # 5, the operating budget) The Board of Selectmen Recommends this Article.

## Article moved by A.Boutin, second by M. Carver

Department Head Fred Garafalo spoke to the article. Current operating budget is shared by Landaff and Lyman. Fred thanked all for helping to make the recycling end a success. F.Garafalo explained that the current Skid Steer is a 2000 model with 5,000 hours of operation on the machine. He also explained that Landaff and Lyman would be contributing cash to the purchase of the new Skid Steer .

P.Wold-Question as to impact on tax rate

It was explained that with the current situation in the town it is difficult to assess the impact if indeed there would be any

T.White-Question as to trade-in

F.Garafalo – trade-in value is estimate at Three Thousand (\$3,000) to Four Thousand (\$4,000)

R.Page - Question as to life expectancy of Skid Steer

F. Garafalo – explained that it is approximate Three to Four Thousand hours. He estimates that the town uses this piece of equipment at a current usage rate of 50 hours per week.

Ayes have it, article passes

## ARTICLE 4: Dump Truck Lease

To see if the Town will vote to authorize the selectmen to enter into a long-term lease/purchase agreement in the amount of One Hundred Seventy-Five Thousand Dollars (\$175,000) payable over a term of seven years for a new dump truck for the highway department, and to raise and appropriate the sum of \$106,000 for the initial down payment with said funds to come from the Dump Truck Capital Reserve Fund. REQUIRES 2/3 MAJORITY VOTE TO PASS. (This appropriation is addition to Warrant Article # 5, the operating budget) The Board of Selectmen Recommends this Article.

## Article moved by M. Carver, second by A. Boutin

C. Hampson spoke as to the need for this piece of equipment. Currently the town operates with a 17 year old 6 wheeler and the new truck would be a 10 wheeler allowing the town to move more material in a shorter period of time.

N. Brown – questions on the lease

D.Blodgett – explained that the select board voted not to include a Twelve Thousand Dollar (\$12,000) line item for an extended warranty.

D. Burnett - Is this a replacement or an extra vehicle

C. Hampson - Replacement

D. Lafond - question on the risks of not taking the extended warranty

C.Hampson - currently the town has included Thirteen Thousand Dollars per truck per year for maintenance and it was determined that although it is a calculated risk to not take the warranty on advice and review of other towns the board elected to pass on the extended warranty.

R.Pride - question as to the need for 2/3's majority

It is believed that the need depends on either amount, length of lease/loan or both and it was discussed that because counsel was not available it was best to ere on the side of caution.

Moves to ballot vote

Covers TA, selectman and administrative assistant

C. Derosia - Last year's highway was 387000, this year 488000, can that be explained?

Believe this may have been as the previous Board was going to employ a new Superintendent of Highways at \$65000.

D. Burnett – Are we voting on each line or the bottom line, can we make changes? Voting on the bottom line, amendments can be made to any line, but that would eventually just change the bottom line figure.

General questions and comments on budget and highway. K. Clement was asked to speak on Highway Budget. He explained what he had presented when asked to prepare budget when he was the Department Head. He also explained that part of reason for difference from last year was that the block grant monies had been added into the line.

- B. Edwards If we no longer have the leadership that prepared this budget, why are we voting on an amount for a Superintendent that we might not need.
- J. Northrop The overall budget looks down, so better to vote as is and allow the people coming in the ability to work with it. Had a chance to quickly look over it and feel it is a pretty good budget. The new Board will need to make decisions on if new person in Highway and new TA need to come on Board. Any monies left at end can help to reduce taxes.
- G. Jesseman General question in light of the resignation of the Board what legal obligations the Town has to all of the decisions made by the previous Board.
- J. Trelfa This morning I spent time on the phone with the secretary of State's office, the AG's office, the DRA and Town Counsel, the aim was to work out how to have a legal election and Town meeting. This situation is a first for the State, so we are getting through today to have a budget to work with. Tomorrow we will be working on what is next, hopefully with one elected Selectman. If anybody has questions, please let us know what they are so I can ask Counsel. They were all very helpful getting us to this point. I am very grateful for the three people we have as Selectmen for the day, and that is all they are, once we are finished tonight their term is up. Hopefully everybody will pull together and we will move forward.
- G. Jesseman I think everybody wants to move forward and work together on this.
- J. Doyle I would like to go back to the amount for highway, why are we voting for an amount more than last year.
- K. Clement The department operating budget and the Block grant monies were added together and presented as one amount this year. In the past they have been separate, but the amount has to be shown.

## ARTICLE 7: Water Dept. Funding

To see if the Town will vote to raise and appropriate the sum of Two Hundred Five Thousand One Hundred and One Dollars (\$205,101) for the operation and maintenance of the Lisbon Water Department. Funds are to be raised from user fees no funds from taxation (This appropriation is addition to Warrant Article # 5, the operating budget) The Board of Selectmen Recommends this Article.

Article moved by M. Carver, second by A. Boutin

D. Burnett - Question on how much it has gone down.

It is a contracted service and there is no one here to answer.

R. Pride – It showed on the spreadsheet handed out at the budget hearing that the maintenance line was reduced, there had been maintenance work done last year and so that line has now been reduced.

Ayes have it, article passed.

## ARTICLE 8: Wastewater Funding

To see if the Town will vote to raise and appropriate the sum of Two Hundred Twenty-One Thousand Six Hundred Eighty One Dollars (\$221,681) for the operation and maintenance of the Lisbon Wastewater Department. Funds to be raised from user fees and no amount to come from taxation (This appropriation is addition to Warrant Article # 5, the operating budget) The Board of Selectmen recommends this Article.

## Article moved by A. Boutin, second M. Carver

D. Blodgett – Sewer is based in part by the water bill. What happens about people who water animals and it doesn't go down the sewer. If it doesn't go into the sewer we shouldn't be charged.

General conversation about pools and water.

M. Pettricone, move the question, M. Carver second Ayes have it, question moved.

Ayes have it, article passed.

## **ARTICLE 9: Fund Capital Reserve Accounts**

To See if the Town will vote to raise and appropriate the sum of Twenty Seven Thousand Five Hundred Dollars (\$27,500) to be placed in the following Capital Reserve Accounts (This appropriation is in addition to Warrant Article # 5, the operating budget) The Board of Selectmen Recommends this Article:

- \$5,000 Highway Equipment Capital Reserve Fund
- \$5,000 Fire Equipment and Building Capital Reserve Fund
- \$7,500 Police Equipment Capital Reserve Fund
- \$5,000 Life Squad Capital Reserve Fund
- \$5,000 Transfer Station Equipment Capital Reserve Fund

- R. Cook motion to move the question. Ayes have it.

## ARTICLE 10: Discontinue the Lisbon Life Squad Ambulance CRF

To see if the Town will vote to discontinue the Lisbon Life Squad Ambulance Capital Reserve Fund, said funds, with accumulated interest to date of withdrawal, to be transferred to the Town's general fund. Passage of this article is contingent upon the passage of the ARTICLE 11. The Board of Selectmen Recommends this Article.

R. Cook - We have had some discussion about this with the previous article. Does anybody have any questions.

Ayes have it article passed

## ARTICLE 11: Establish Lisbon Life Squad CRF

To see if the Town will vote to establish a Capital Reserve Fund under the provisions of RSA 35:1 for the purpose of the Lisbon Life Squad Capital Reserve Equipment Fund and to raise and appropriate the sum of \$5,000 to be placed in the fund with said funds to come from Unassigned Fund Balance. Furthermore, to name the Selectmen as agents of said fund. Passage of this article is contingent upon the passage of ARTICLE 10. The Board of Selectmen Recommends this Article.

## Article moved by M. Carver, second A. Boutin

- J. Raia Can you explain the Selectboard being agents.
- D. Combs It means that if we have an issue and need something, we can go to the Board and they have the authority to spend the money without having to have a special meeting to ask the towns peoples permission.

Ayes have it, article passed.

## ARTICLE 12: Grove Hill Cemetery Plots

To see if the town will vote to deposit funds, received from the sale of Grove Hill Cemetery plots and from tomb rental fees, into the Cemetery Maintenance Fund, which is maintained by the Trustees of the Trust Funds. These funds have been used for maintenance purposes in

the past, but the Cemetery Trustees have been advised by the New Hampshire Department of Justice that the use of these funds in this manner requires the approval of the voters of the town. Funds received to cover the cost of burials in Grove Hill Cemetery will be transferred to the town general fund in order to offset the wages paid to the town employees who perform these burial services. (Simple Majority) The Board of Selectmen Recommends this Article.

Article moved by M. Carver, seconded A. Boutin.

M. Petriccione – Trustee of Trust fund. Explained Cemetery gone from private to Town, changed mandate. Attended training and found out what should be done by the Town. Tomb maintenance includes replacing, repairing stones. Funds had always been used but now under control of Town we need the approval of the Towns people.

R. Cook – as need a simple majority going to do by hand count. Ayes 114 Nahs 0

Ayes have it article passed

T. Andross – I move that we pass over Article 13 C. Derosia – Second

R. Cook – Going to vote to see if you want to pass over Article 13 Ayes have it, motion to pass over Article 13 passed.

#### ARTICLE 13: Adopt SB2-By Petition

To see if the town will vote to adopt the SB 2 system (Australian ballot) which changes the way a municipality and/or school district operates. Rather than one traditional "town meeting" format, in which residents gather, consider, debate and vote on issues, the process is divided into two steps: First, there is a "deliberative session" in which residents talk about articles on the annual warrant, consider them and, if they choose, make changes to them. Second, they take a final vote on everything by secret ballot at the polls on Election Day – the same way the currently choose between candidates for office and decide on zoning amendments. So, if you cannot or don't want to go to Town Meeting, or are out of town, you can still have your vote counted. (Petitioned Warrant Article)

Article passed over.

## **ARTICLE 14: Eliminate Town Administrator Position**

To see if the town will vote to eliminate the position of Town Administrator and authorize the Board of Selectmen to hire the services of a temporary contracted service to oversee the daily operation of the Town under the direct supervision of the Board of Selectmen. This temporary contracted service would be a non-benefited position for the remainder for the year 2017 and until the Annual Town Meeting of 2018. Also to authorize the Board of Selectmen to establish a research committee consisting of members of the community, and town and school employees to research and conduct a needs assessment for the position and/or the need to hire for the position or retain the contracted service in the future. This contracted service and any costs associated with the research committee shall be funded from the existing Administration line set forth in the Town Operation Budge and shall not be funded by any additional taxation. (Petitioned Warrant Article)

## M. Carver moved the article, second A. Boutin

- L. Winter This article seems to be cobbled together and trying to do three things all at the same time. I am just saying that although I might agree to one point or another in its entirety I would have to vote against. Is there anybody here who can explain the thinking behind this.
- J. Jones How will we know how much this article is going to cost, how much is an outside contractor going to cost.
- R. Cook Explains in article shall be funded from the existing Administration line and shall not be funded by additional taxes.
- J. Trelfa Anybody that was at the Budget hearing correct me if I am wrong. When they went over the Administration line at the Budget hearing they put in what they thought a contracted service would cost for the rest of the year.
- M. Jock This is a petitioned article not something the Selectmen recommended.
- R. Cook Correct.

General discussion on what the article covers and what was intended by it. Concerns that Towns people should be involved with if a TA is required and then if yes, choosing one. Is it a most point to vote on it as we no longer have a TA and the previous Board had decided to go forward with a committee.

If we vote not to eliminate the TA position does that mean the Town has to hire a TA? No's from various people.

If this gets to vote and we vote no, does it just go away?

If it fails we just carry on. If we vote this down the new board will be able to hire a TA if they want one? Yes, the money has been appropriated.

Like a previous article, we are not tying the hands of our new board, sure the new board are going to want a board to help them and putting the article down gives them the flexibility to do their good work.

- D. Butson move the question about 10 seconded from floor.
- R. Cook No more discussion, all those in favor of moving the question Ayes have it.

Nahs have it, article fails.

### ARTICLE 15: Discontinue CRF's and ETF's

To see if the town will vote to discontinue the following Trust of the Trustees accounts:

Fire Station CRF

Highway Pickup CRF

Backhoe CRF

Revaluation CRF

Highway Dept. Heavy Equipment CRF

With all funds including interest to be transferred to the town's general fund.

A. Boutin – If I remember correctly from the Budget Hearing they are just trying to rename some of these with dates as not named correctly. The monies goes into the General Fund, then in the next article they are re-established and the money can then go back into the renamed trust funds.

D. Clark - Move the question. G. Paige - second

We have a move the question, discussion is over. Ayes have it to move the question

Ayes have it, article passes.

## ARTICLE 16: Include Year of Creation on CRF/ETF

To see if the town will vote to include the date of creation in the following Capital Reserve and Expendable Trust Fund Titles for clarification purposes; Highway Dept. Backhoe CRF 1993, Revaluation CRF 1997, New Highway Dump Truck CRF 1998, Employee Health Insurance ETF 2001, Life Squad Vehicle CRF 2002, Library Addition CRF 2005, Wastewater Dept. ## Trustees of the Trust Funds 2017 Annual Report

We are pleased to report that this past year has exceeded the previous year in terms of market conditions; accordingly, our investments have had an overall increase of as much as 13%,

As many of you are aware, our Jennie Eastman Brown Fund provides scholarship funds to Lisbon Regional High School graduates who attend college and maintain a minimum Grade Point Average; last year we were able to provide each qualifying student a scholarship grant of \$1,000, this year we were able to award each student with a \$1,500 scholarship grant. Again, the Board applauds those students who have received scholarships for their academic achievement.

We remain concerned that there were very few requests this past year for assistance from the Buffington Fund. As a brief review, this fund was established to provide medical assistance to needy residents who qualify for assistance and was last modified by the court in 2001 as follows:

- Care of Town's residents who are deserving patients at any other general care hospital, wherever located, who have been transferred from Woodsville Cottage Hospital
- 2. Care of Town's residents who are deserving patients at any other general care hospital wherever located
- For other medical/dental care of deserving Town residents including care by physicians, dentists, and nurses and medical and/or dental prescriptions
- For the care of the Town's deserving needy for needs other than medical expenses including housing, food, etc. commonly paid for by Town Welfare or for purposes such as eye care, examinations and glasses.

If a needy resident qualifies for assistance all that is necessary is to file an application with the select-board, if approved the board will send a request to the trustees for payment and we will pay the medical facility directly—the recipient/beneficiary's names are kept strictly confidential.

The Common Investment Fund provides money that is distributed annually to the town, library and cemeteries and the Grove Hill Cemetery Perpetual Care Trust provides funds for the repair of memorial stones and other maintenance.

The board keeps a very close watch for fluctuations in the market and, along with the advice of the Passumpsic Advisors, make changes when necessary to ensure that funds entrusted to our care produce the greatest return with the lowest downside risk.

- In 2017 Mary Lou Forsyth became Secretary after Steven Morrison left the Board.
   Selectman Brian Higgins replaced Peter Nightingale as the Select Board Rep. and
   Sara Jean Hicks joined as our new Alternate.
- The Board reviewed and voted on several site plans in 2016, and several Lot Line Revisions and a two lot Subdivision in 2017.
- In 2016 -Master Plan. We conducted a Community wide survey of town residents to determine how the town residents wish to see the town progress over the next 10 years. We had a healthy response with many thoughtful and helpful comments. We held a series of meetings with civic groups, town businesses and the general public to expand upon the survey. We hope this year (2017) we can start the final drafting of the Master Plan for presentation to the town. As part of this process in 2017, we are coordinating with students from Plymouth State University to prepare studies regarding local residents and students opinions, reviewing the Town's internet visibility, preparing some marketing materials all as part of their degree curriculum studies.
- The Board reviewed and updated our Zoning Regulations in 2016/2017 with special focus on Site Plan requirements to allow for careful development that will benefit the Town. North Country Council Senior Planner Tara Bamford guided us through the process and provided a huge amount of support and professional input.
- The Board also reviewed and updated our Subdivision Regulations in 2016/2017, again with the vital assistance from Tara Bamford. Both sets of regulations were approved and are now officially adopted.
- In 2016 the Board also reviewed permit application fees and updated them, and in 2017 a written stipend policy for Board members.
- In 2017 we signed Consultancy agreements with Horizons Engineering and Tara Bamford Consulting Planner to provide professional reviews of applications on behalf of the Town, these fees for these reviews are reimbursed by the Applicant.

- In 2016, at the request of the Selectboard, the Planning board was reviewing the
   Capital Improvement Plan with the Town Administrator. We had planned to have
   some recommendations finalized and were compiling a list of town roads with the
   status of gravel/paved and mileage to assist future planning for road upkeep. That
   process was postponed in early 2017.
- A member of the Board is serving as a representative for the Town at the North Country Council quarterly meetings, a position that had been vacant for several years.
- We have submitted a budget for this year (2017) to include some training for Board members, a workshop to start a review of our Zoning Ordinances in conjunction with the updating of the Master Plan with a goal to bring them to the Town Meeting in 2019 for voting by the Town's residents
- A sincere thank you to all members of the Planning Board, the Town Administrator, town staff (Jennifer Trelfa and Krystle Dow), and Tara Bamford for all the time and energy that they have expended on these projects these last two years.

To the residents of Lisbon

I would like to thank everyone for your continued support. This year has brought a number of changes and continued challenges for this agency and law enforcement as a whole, however as a result of your support we have made it through one of the biggest challenges that I have experienced in my career in Lisbon. For that I thank you.

This year the Lisbon Police Department had conducted several large fentanyl investigations. As a result we have put a dent in the sales in this community. This agency has been working collectively with other agencies to include the Drug Enforcement Administration in order to stop the flow of fentanyl/heroin in our communities. I would like to think that our efforts are making a difference.

In July of this year the Lisbon Police Department assumed patrol of Landaff. This is a 5 hour per week venture that brings to the Town of Lisbon an annual revenue of \$15,600. We have included the patrols randomly into our normal patrols. While engaged in patrol in the Town of Landaff we deal with calls for service as well, however retain the right to turn over any timely investigations to the NH State Police in order for us not to be taken away from our duties in Lisbon.

We have also been inundated with other felony crimes this year ranging from sexual assaults to burglaries. We do our best to be proactive, however with a decrease in manpower several years ago, the increase in criminal cases have placed a greater burden on each individual officer as well as myself as the prosecutor.

As with many years now, we continue to apply for and receive State and Federal grants that are used for directed patrols such as seat belt enforcement, DWI patrols, distracted driving, and speed enforcement. We have seen an increase in negative driving behaviors on our roadways and these enforcement initiatives will aid us in reducing these behaviors. Please contact us if you are concerned with the operation of a motor vehicle. Our goal is to save lives and you can assist us with that intervention.

## **Transfer Station**

Thank you to the people of Lisbon, Lyman, and Landaff for your support of the transfer station and your efforts to recycle as much as possible.

Most importantly 2017 was a safe year at the transfer station With all the pedestrian and vehicular traffic through the transfer station every day we are open there were no incidents or injuries reported.

On the financial side we recovered 83.4% of the transfer station operating costs from the sale of trash bags, and income generated from construction/demolition material weighed on our scale. The actual cost to runt the transfer station for Lisbon is \$16,913, Landaff is \$4,295 and Lyman \$5,638. Hopefully next year we can do better. The income for the transfer station is shown in the table below;

Greetings from the highway garage,

I would like to extend a most sincere thank you to the town's people of Lisbon for the support given to this department. Many storms occurred throughout the previous year and all of us at the highway garage appreciated the patience and kind words given to us as we move forward.

Also in show of support, we received a new 10-wheel dump truck. Our first new big truck since the year 2000. A replacement to the 2008 pick-up occurred in February after an engine failure in December. The Lisbon Regional School was very gracious to allow us the use of their truck as we worked on how, or if, we were going to replace that pick-up. Thank you Chris Leavitt!

Paving was done on Dickinson, High, and Goudie streets. A shim coat of asphalt was applied to Bath road. For 2018, shim will continue on Bath road towards the recycling center and the town line, completion will probably take another couple years. We also plan to grind the further end of Bishop rd. and pave with at least a base coat of asphalt to the golf course area. The plan for completion is to overlay the remaining length of that road next year. To the residents of Bishop road, thank you for many years of patience.

After many years of planning, we finally have a respectable time frame associated with reading our water meters. Down from originally taking two weeks, to just over 6 hours. The town is also going to be reading the meters three times a year. The purpose is to catch any leaking problems sooner. This should help us be more cost effective in our service to the community. We will also be focusing on replacement of some hydrants this year.

Finally, due to circumstances beyond our control, Welch's Water/Waste Service is no longer working in Lisbon. All of us from the highway garage salute the Welch family for the decades of service to the town of Lisbon. Many a family function was missed while Terry and his crew were busy keeping the water and wastewater facilities operating through all kinds of weather. ## Lisbon Life Squad

Another year has passed and the Life Squad would like to thank all the residents of Lisbon, Lyman and Landaff for their support this past year. We would also like to thank the area businesses for allowing our members to respond to incidents within our coverage area. We would not be able to provide the level of care we do without all of your support.

The Life Squad responded to 234 calls last year. Of the 234 calls, 173 were in Lisbon, 32 in Lyman, 17 in Landaff, 5 in Bath, 5 in Haverhill/Woodsville, 1 in Bethlehem and 1 in Groton Vermont. Our call numbers were slightly down from last year.

The new ambulance that we purchase in January 2017 has been a huge asset to the Life Squad. We have been able to respond safely and without mechanical failure delays to all calls.

The new training system that we started last year with Mr. Ed Daniels is working well for the Life Squad. He provides monthly training during the Life Squad's monthly meeting which covers required National Registry as well as state required topics. Training in house eliminates/reduces the need for each licensee to seek out ways to complete their continuing education on their own time. Every licensed provider is required to recertify every two years. Each level of licensure requires a different number of continuing educational credits. Emergency Medical Responders need 16 hours, Emergency Medical Technicians need 20 hours, Advanced Emergency Medical Technicians need 50 hours and Paramedics need 60 hours. The state of NH implemented new Patient Care Protocols January 1, 2018. All NH providers are required to be familiar with contents of the protocols that are pertinent to their level of training.

We are very thankful to have had many contributors who donated to the Life Squad during the year on an individual basis. Many businesses and groups such as the Stump jumpers snow machine club; and the Norumbega Trail Riders group have made monetary donations as well as donated several pieces of equipment to the Life Squad.

Moving forward; we are hoping to receive the town's support to construct a new Emergency Services building for the Fire Department, Life Squad and Emergency Operating Center.

ACHS has been providing comprehensive primary preventive health care to anyone, regardless of their ability to pay since 1975. Support from the Town of Lisbon is extremely important in our continued efforts to provide affordable health care services to the 26 rural towns in our service area. Our sliding fee scale for payment of services provides a vehicle for uninsured and underinsured patients to get the health care they need in a timely manner. Keeping just one patient out of the ER could save taxpayers \$1,500 -\$2000 (average cost of an ER visit).

Access to affordable dental and oral health care is difficult for many in the North Country who lack the means to pay for these services. Poor oral health can lead to many other serious health issues and often leads to costly hospital ER visits where the actual causes of the problem cannot be addressed. ACHS opened the first community oral health program in northern New Hampshire on the ACHS-Littleton campus in January of 2015. This program is available to all and we offer a sliding fee scale for payment to those who qualify. ## Town Specific Annual Report 2017 - Lisbon

North Country Home Health & Hospice Agency provides quality services that include home health, hospice, nursing, rehabilitation, social services, homemaking and long-term care in 48 towns, covering all of Coos County and northern Grafton County. In 2017, for the Town of Lisbon, we provided 2,076 visits with services to 45 clients (10 of which were Hospice and the remaining were Home Health and Long-Term Care clients). We are committed to our community in that we provide community health clinics and screenings such as blood pressure checks and foot care clinics, health education programs, and a bereavement support group.

Hospice Care focuses on quality of life and provides support to the patient and their caregivers in achieving their goals and wishes. Our compassionate team, made up of physicians, nurses, social workers, home health aides, spiritual counselors, therapists and volunteers, work with the patient to achieve their goal. Services provided to the patient and their caregivers include: management of pain and symptoms, assisting patients with the emotional, spiritual and psychosocial aspects of dying, and provides needed medications, medical equipment and medical supplies. Also included is family/caregiver education on the provision of care and short-term inpatient treatment for management of symptoms that cannot be managed in the home environment or is needed for caregiver respite. Bereavement counseling for surviving family members and friends is also provided. An individual electing hospice care is not giving up on living, rather, making the decision to focus on quality of life. Hospice care provides a high level of quality medical care with a different focus from the traditional medical model.

Home Health Care is critical to serving the growing health care needs of this community. Our skilled clinical team can monitor health problems and provide disease management within the comfort of the home setting, which helps prevent more costly health care such as hospitalization and long term institutional care.

North Country Home Health & Hospice Agency and our Board of Directors are extremely grateful to the Town of Lisbonfor its support of our agency. This allows us to fulfill our mission to provide services to all individuals regardless of their ability to pay. North Country Home Health & Hospice Agency is committed to providing services in Lisbonto support clients and their families to remain in the comfort of their homes, in a safe and supportive environment, and to improve overall health outcomes in the community.

As we prepare to for the 2018 year, I first want to say thank you for giving me the honor to represent you in the state legislature.

In 2017, the state legislature has made accomplishments such as a responsible two-year spending plan with no new taxes or increased taxes and meets the needs of our state and towns now have the ability to receive grant funding for full day kindergarten through Keno revenues which includes the half day kindergarten option. During the 2017 session, the legislature also passed SB 38 for additional block grant funds, which anticipates Lisbon earning \$67,230.30 for roads and bridges.

I want to thank all of my constituents who have shared their input and concerns on a variety of issues. We have a great year ahead of us and look forward to hearing from all of you during this coming year. To the Constituents of Lisbon:

As you determine your town and school budgets for the next year, I appreciate the opportunity to share with you some of the positive recent accomplishments of the New Hampshire legislature.

A 2 year budget was passed that did not increase taxes and fees and meets the needs of our citizens without any downshifting to towns. Health and Human Services saw an increase in their budget of 7%, more than any prior budget. The increase will provide more mental health services including aid to those struggling with drug addiction. The Business Profits Tax and Business Enterprise Tax were reduced making New Hampshire more competitive in attracting and retaining jobs and growing our economy.

Of particular note, this legislature provided \$36 million to towns in the form of road and bridge aid to help towns address infrastructure needs. Lisbon received \$67,230.

While I do not want to end my letter to you on a down note, it is imperative that all property owners be aware that House Bill 324 is headed to a commission to work out a compromise between towns and utilities. The utilities claim they pay too much in property taxes which substantially increases electric rates for consumers. Many North Country towns stand to lose revenue if a compromise passes the legislature in 2019, translating into higher property taxes for local taxpayers. Please attend hearings, write letters and support your selectmen and legislators as we work to halt any legislation which would hurt local taxpayers and put pressure on school and town budgets.

As always, it is an honor to serve you in the New Hampshire House of Representatives.

## Report from Your North Country Senator Jeff Woodburn



#### Dear Constituent,

It is an honor to serve as your State Senator representing District 1, which includes 58-rural, northern communities, encompassing 28 percent of the state's landmass. It is a region larger than two states and 17 foreign countries and containing fewer than twenty people per square mile.
